



#### The Mid Sussex draft plan







On December 13<sup>th</sup> 2023, Mid Sussex District Council (MSDC) voted to move to Reg 19 consultation (every councillor except 1 independent voted for this)

## Planning Process since last meeting



- Mid Sussex consulted on the final draft of their District Plan in Jan/Feb this year (Regulation 19)
- On 8 July, 19 weeks later, after a long silence, the Plan was submitted to the Secretary of State
- We learned that 1,359 comments were made by 1,335 respondents.
- 554 comments related to the 'significant sites', including 388 about Albourne/Sayers Common, of which 384 said the site allocations were unsound
- The Council proposed a large number of minor changes to the Plan as a result. None came from a local resident...

## **Planning Inspector Examination**



- The Secretary of State has appointed Miss Louise Nurser to examine the plan. You can find guidance she has published on the Council's website (Inspector's Documents)
- Miss Nurser has divided the examination into 2 stages
- In Stage 1 she will consider 'some fundamental issues that need testing'. This will take place in the two weeks beginning 22 October, sitting for three days (Tuesday-Thursday) each week
- WILD has submitted hearing statements for Stage 1 matters
- Stage 2 will be organised when Stage 1 has been successfully completed, and will 'consider the policies in the Plan in more detail' including e.g. Biodiversity

#### Examination – Stage 1



- Stage 1 will consider 6 'Matters' :
  - Legal and Procedural Requirements
  - Duty to Cooperate
  - Vision, Objectives and Spatial Strategy
  - Transport
  - Flood Risk
  - Housing
- The hearings calendar allocates one or more sessions to these topics

## WILD progress since Reg 19




- 1. We have commissioned 2 studies one on Viability, one on Active Travel
- 2. We have engaged the services of a barrister from FTB Chambers
- 3. We have submitted four hearing statements
- 4. We will attend the Examination !

## Examination – WILD focus areas



- 1. Legal & Procedural Sustainability Appraisal (SA) is used to assess all reasonable strategic options. It used a flawed scoring methodology and applied it inconsistently; and it did not consider all reasonable alternative options
- 2. Vision, Objectives and Strategy In the inspector's view, 'There is no explicit strategy within the Plan as submitted' and we agree. It is not possible for the Albourne and Sayers Common sites to be a 20-minute neighbourhood.
- 3. Transport these issues were not considered at the earliest stages of plan making as they should have been, and the transport evidence is based on unsound assumptions
- 4. Flood risk The flood risk assessments were produced too late to inform the Plan. Site reports for Sayers Common and Albourne say <u>there is no recent/current history of flooding and</u> <u>there is no record, ever, of any sewage problems !!</u>

#### **Bikeability Levels**





The proposed cycle route is too long and not safe for the average user

2 safe cycle routes (Level 2) would cost £5.3m


#### To recap our concerns are:

- Ours is a sacrifice that MSDC is prepared to make !!
- Our community has not been engaged properly
- Unacceptable impact to rural landscape and biodiversity
- Transport
- Merging of Sayers Common and Albourne (a 100m gap is not a gap)
- Infrastructure has not been properly costed our report shows a £66m gap. This would mean loss of affordable housing and facilities, to protect profit margins
- Flooding continues to be an issue for our area
